Meeting Notes March 19, 2018

Call to Order:

Role/Welcome/Attendance:

All board members present and community members are on the attached list. Mr. VanLoon was present to discuss some options with contracts with Coke and/or Pepsi. See new business.

Approval of Minutes:

Motion made by Kris Emery and 2nd by Lynn Becklin to approve the minutes from the February meeting. Motion carried.

Agenda/Review of topics:

Added Mr. VanLoon to the new business section and also added closed session meeting after public comment.

Treasurer's Report:

Hailey Mabrito went over the treasurer's report and shared we are current on all expenses. Our current balance in the account is \$19,028.23. A motion was made by Kris Emery and 2nd by Dustin Drummond to pay the Liability Insurance and Food License reimbursement to the school, as well as we paid for the Alumni T-shirts to Ink Link in the amount of \$442.90. Motion carried. The estimated income from everything at the alumni game was approximately \$1600.

Committee Reports:

General Fundraising-

Matt Parker spoke to everyone in regards to the success of the <u>Alumni Game</u>. We all heard positive comments from people in the community regarding the alumni game and hope to have it again in the future with a few changes! (Not during March Madness). Only 1 serious injury occurred at the alumni game with someone going to the hospital and having to have surgery. Waivers were signed by all competing athletes to protect our club and school from something like this happening to avoid recourse.

<u>Kubasiak 5K</u> – We are advertising on Facebook, Website and on the Kubasiak page. Please encourage people to sign up for this event. The course/route has been set up and as soon as it is provided, it will be posted on all the sites mentioned above. Still waiting on t-shirt design, but hopefully will have that soon.

<u>Buick Fundraiser</u>- Picked days in April to work with test driving cars to make money for the athletes. Still struggling to work with dealership, but when it is confirmed, we will post on website and facebook. In order to participate, you must be 21 years old, have a valid ID and proof of insurance. For each test drive, we receive money (I believe \$10). Very easy fundraiser for the community to participate in.

Golf Outing- As soon as Spring Break is over, the golf committee will be communicating with business' regarding hole sponsorship and donations. \$100 for hole sponsorship and we are looking to have many exciting things happening during the outing, including a possible hole-in-one contest. Spirit Store: Lynn Becklin reported that there is nothing new to report.

<u>Concession Stand:</u> Dustin reported that concessions did great during Boys Districts but struggled a bit with the Alumni game due to the Friday night times, the community fish fry, etc. Getting ready for the baseball/softball season and trying to get things ready in that SMALL concession stand. Also, Spots are still open on sign up genius to work concessions for these events as well as Kubasiak 5K.

Athletic Directors Report - Kyle Jawor

- Spring Coaches are in place. Hired a JV Softball coach from Albion. Ms. Straton will be working with the girls softball team ASAP.
- BSN equipment (spirit shop). Kyle is looking to work with BSN vs. VNN to get a kick back when we buy equipment and uniforms, etc. Still looking into this. Hope to have more information by next meeting.
- Signing day at Alumni Game- Many people thought this was a great idea to not only have kids commit to trying out for a team, but to gain contact information from parents to add to our communication lists for liaisons. This was designed by Coach Samuels to get kids excited about high school sports. Mentioned trying this at another event besides the Alumni game to get more kids to attend.
- One community member disliked the idea of the "signing day" because they felt it may have misled the students to think they had already made the team. It was just a "signing of interest" and didn't guarantee the student would make the team. Still, the parent did not like this.

Liaisons Report:

- Because BABR plans to distribute funds to programs in June, it is required that coaches fill out the money request form that is on the website to get the funds they need and what they will need it for. Please know that the money will NOT be given or requested by the liaisons. Requests must come from the coaches and be given to Kyle for approval before they are submitted to BABR.
